which VII wishes to associate, and, (V) be in accordance with the Terms of Service, as applicable, of Facebook (https://www.facebook.com/terms.php), Instagram (https://help.instagram.com/1215086795543252) or Twitter (https://twitter.com/en/tos). You must own the rights to each element of the User Content video you submit (excluding rights to the Song, which are provided by VII) and the right to grant all of the authorizations, permissions, approvals, consents, rights and licenses as described in this Submission Agreement. - (e) <u>Selected User Content</u>: VII may, but has no obligation to, select your User Content video for inclusion in the Promotion and, in such event, VII shall notify you via direct message on Facebook, Instagram or Twitter, as applicable. You must return a signed copy of the Submission Release (as defined below) which is satisfactorily acceptable to VII within two (2) days from receipt in order for your User Content video to be eligible for inclusion in the Promotion; failure to do so within that timeframe will result in your User Content video to be deemed ineligible to appear in the Promotion.
- 2. Application. You are signifying your agreement with and acceptance of all terms and conditions of this Submission Agreement and the Terms of Use Agreement each time you submit User Content (as defined below) to VII via email, via any technology or feature that we make available, using one or more hashtags (as we specify) on a social media service and/or using other generally accepted methods of aggregating content and/or directing content to a third party through a social media service ("Submission Methods") in connection with a request by VII or VII Affiliates (as defined below). 3. Submission of User Content.

(a) The term, "User Content," means and refers to any and all content, media and materials you submit to VII using the Submission Methods, including, without limitation, still photographs, writings, spoken statements, music, audio, video, video recordings, audio-visual works and recordings, slides, portraits, animated and/or motion pictures, caricatures, likenesses, vocal or other sounds, sound recordings, voices, voice reproductions, computer graphics and visual effects, as well as any accompanying documentation, packaging or other materials, tangible or intangible, and to all derivative works, translations, adaptations or variations of same,

- (c) VII and the VII Affiliates have the right to assign, transfer, convey, license, sub-license and otherwise transfer, sub-contract, delegate, outsource or engage third parties to perform or benefit from all or any portion of its or their rights and/or obligations to any one or more other parties without accounting, reporting, notification or other obligation or liability to you whatsoever, now or in the future.
- (d) Notwithstanding the foregoing, you acknowledge and agree that neither VII nor any of the VII Affiliates will be obligated to take advantage of any or all of the particular rights granted above, and VII and the VII Affiliates shall have the right, in its sole discretion, to remove any User Content at any time for any or no reason. You are not entitled to and you will not receive any compensation or other consideration for your User Content or any use made of your User Content once submitted in its discretion.

5. Release.

- (a) You hereby release VII and the VII Affiliates from any and all claims of any rights, encumbrances, liens, claims, demands, actions or suits which you may or can have in connection with your User Content, including, without limitation, any and all liability for any permitted use or nonuse of the your User Content, claims for defamation, libel, slander, invasion of privacy, right of publicity, emotional distress or economic loss. - (b) You acknowledge that other persons may have submitted User Content to us, may have made public or developed, or may originate, submit, make public or develop, material similar or identical to all or a portion of your User Content or concepts contained therein, and you understand and agree you will not be entitled to any compensation because of the use or exploitation thereof and the submission of User Content, or any posting or display thereof, is not any admission of novelty, priority or originality. Even if you subsequently see or learn of a presentation, motion picture, still photograph, film, video or any other content which appears to incorporate any idea or concept or include anything similar or identical to that contained in any User Content you or anyone else submits, that is purely coincidental and unavoidable.

- 6. Ownership. - Representations and Warranties. You represent, warrant and covenant that (a) you own the User Content you submit and/or have all rights in such User Content to grant all of the authorizations, permissions, approvals, consents, rights and licenses as described in this Submission Agreement; (b) all of the information provided by you associated with your User Content is correct, complete and current; (c) your submission of any User Content does not violate this Submission Agreement, and such submission and exercise of the rights you grant to VII and the VII Affiliates in the User Content, shall not violate any rights of any other party, any of your obligations, any law or regulation or infringe upon or misappropriate any intellectual property, privacy, publicity or other rights of any party; and (d) you hold and will continue to hold all the ownership, license, proprietary and other rights necessary to enter into, authorize, grant rights and perform your obligations under this Submission Agreement as described.
